### **CASHBACK OFFER TERMS AND CONDITIONS (CAULIFLOWER AND COURGETTE PIZZA CRUST)**

- The offer applies to pizza crusts purchased in the period from 16 September 2020 to 30 November 2020, both inclusive.
- The cashback offer applies only to the Magioni cauliflower pizza crust and the Magioni courgette pizza crust;
- The cashback offer is for 1 product purchased;
- The offer only applies to Magioni cauliflower pizza crusts and Magioni courgette pizza crusts purchased at a supermarket in the Netherlands or Belgium;
- Cashback requests can be submitted only on this Magioni website and must be submitted no later than on 30 November. Cashback requests received after 30 November will not be processed;
- This cashback offer can be redeemed only once per person / per IBAN;
- After verification and acceptance of the receipt, Magioni will transfer the purchase price back to the IBAN entered on the website within 14 days;
- If the amount is not deposited in the account within that period, you should lodge a complaint within 6 weeks of submitting the request. We are unable to process complaints received later than that.
- The cashback offer cannot be redeemed in conjunction with other promotions, discounts, and campaigns.

### **CASHBACK OFFER AND USE OF PERSONAL DATA**

If you want to redeem a cashback offer, we will ask you to enter some of your personal data, including your name, email address, IBAN, and the name on the debit card associated with the

IBAN. We need this data to be able to transfer the purchase price of the cauliflower or courgette pizza crust you bought back to your bank account (IBAN, name on debit card). Your name and email address will be used to send you a confirmation of the cashback request and, optionally, to send you our newsletter.

We will keep this data on file for up to 3 months after expiry of the cashback offer. After that, the data will be destroyed.

As part of our own duty to retain data for fiscal purposes, we will retain the following data for a period of 7 years after the cashback offer: Name, IBAN, country of purchase.
